Job Title: Stores Product Coordinator

Purpose (Overview):

Maximize potential Sales & pull through of HB products by ensuring high standards of chilled & frozen product presentation while managing display and stored product ensuring chilled product is cycled as defined in the "Management Processes", tracking product distribution in all Tininga Stores, finding ways to trigger consumer interest, recommending reorder quantities while ensuring 100% of the range is on display and available for sale at all times.

Key Responsibilities:

- Range Ensure 100% of both Chilled & Frozen range is on display at all times in the 3 x designated Supermarkets (Best Buy/ Hagen Central / Dobel Super).
- Range Maintaining full ranges of both Chilled and Frozen small goods presented as per planogram
- Quality Ensure the Chilled & Frozen daily in store procedures follows the details specified
 in the "Instore Chilled & Frozen Management Process Plans"
- Quality Maintain product integrity at all times by ensuring strict adherence to the shelf life schedule as specified in the "Instore Chilled & Frozen Management Process Plans"
- Quality Daily checks and necessary action (applying "special "& "Price Reduction")stickers on short shelf life products ensuring all short life specials are sold out and not sent to waste
- Quality FIFO method of stock rotation must be followed at all times shelf & Freezer displays, cold rooms & freezers
- Quality Liaise with stores freezer Managers/Supervisors to ensure the Daily Temperature checks are completed & strictly monitored 3 x a day... main area to focus is chiller displays.
- Presentation Designing and setting up strong & enticing product displays in both chiller displays and coffin freezers...strong ticketing & product & brand identification
- **Presentation** Assisting with pricing (maintain uniform pricing on the far-left hand conner of the product)
- **Stock Management** Daily Movement of stock from storage area (chiller & freezer rooms) to chiller display area must follow FIFO practices
- Stock Management Daily monitoring of stock levels & assisting/recommending stock orders to Store Management and following up from delivery to stores to both both Cool Rooms & Freezer Rooms to ensure FIFO lay out is maintained

- **Stock Management** Ensure all price reductions are recorded and signed off daily by the Freezer and Stores Managers according to the sign off authority levels
- Stock Management in the event there is any disagreement with Freezer or Store Managers on price reductions then escalate the issue to the Group Retail Manager

Policy and Procedure

- 1. Follow and implement company policies and directives from senior management explaining these to staff under your control.
- 2. Familiarize yourself with the general Tininga Procedure and Policy Manual and be willing to explain to colleague staff.

Personal Qualities and Competencies

- 1. **Teamwork** Is considerate of and welcomes others' views and feedback. Contributes to building a positive team spirit and good morale amongst staff gaining commitment to goals and objectives.
